BUY BACK AND CANCELLATION OF EMPLOYEE SHARE PLAN LOAN-FUNDED SHARES

Adherium Limited (ASX:ADR) confirms 600,000 ordinary shares have now been cancelled as per the previous notification (refer Appendices 3E and 3F lodged 10th May 2018). Following this cancellation, the total number of ordinary shares on issue and listed is 174,273,932.

Consideration paid was the extinguishment of a loan totalling \$300,00.00, originally advanced by the Company to the Shareholder for the purchase of the Employee Share Plan Shares cancelled. No cash was paid by the Company for the buy back.
